- I. The special meeting of the Board of Education of School District 92½, Westchester, Illinois, was held in the Westchester Middle School Gymnasium, at 1620 Norfolk Avenue, on Thursday, October 8, 2020, commencing at 4:30 p.m.

- I.C. <u>APPROVAL OF THE AGENDA AS PRESENTED</u>: A motion was made by Mrs. Quiroz, seconded by Mrs. Ortiz, that the Agenda be approved as presented. - III. <u>APPROVE THE BILLS, CLAIMS AND PAYROLLS AS PRESENTED</u>: Upon the recommendation of the Superintendent, a motion was made by Mrs. Wesolowski, seconded by Mr. Voegtle, that the bills and claims in the amount of \$17,817.48 be approved and authorized for payment. - IV.A. <u>2020-2021 SCHOOL YEAR UPDATE</u>: Currently, District 92½ is in full remote learning until the end of the first quarter. Mr. Salemi reviewed the guiding principles, IDPH guidelines, challenges, opportunities, and rationale to implement a return to school plan following a phase-in approach beginning October 26. The Board discussed the plan. The plan will allow for in-person instruction in a safe setting while slowly transitioning groups of students in to school and is tentative and subject to change.

- IV.B. <u>FINANCE</u>: Mr. Gress summarized the draft audit report provided by Baker Tilly. He noted that revenues exceeded budgeted amounts and expenditures came in under budgeted amounts; both were favorable. The audit was conducted remotely and went smoothly with no issues noted.
- IV.C. <u>BUILDINGS AND GROUNDS</u>: Mr. Gress reported on the status of the Summer 2020 projects. The intercom system at WPS and stage lighting project at WMS are still in progress. Bids for the 2021 summer flooring/asbestos abatement projects will be published the week of October 12; with bids due on November 4 and action to accept the bids anticipated at the November 12 Board meeting.
- IV.D. <u>POLICY</u>: The Board reviewed and discussed Policies 5:10, 5:20, 7:10, 7:20, 7:180, and 7:185. The policies will be brought before the Board for First Reading at the October 22nd Board meeting.
- V. <u>ADVANCED PLANNING</u>: Ideas for recognition of staff will be distributed to the Board for consideration. The October 22nd Regular Board Meeting will be held inperson beginning at 6:30 p.m.
- VI. <u>ADJOURNMENT</u>: A motion was made by Mrs. Quiroz, seconded by Mr. Voegtle, that the Board meeting be adjourned.
